Accessibility Regulations 2018 The Regulations came into force on 23 September 2018 and implement the EU Directive on the accessibility of websites and mobile apps of public sector bodies.

The purpose is to improve the accessibility of public sector websites (including Parish Council sites) so that they can be used by as many people as possible – these builds on the existing obligations to disabled people under the Equality Act 2010 and the duty to make reasonable adjustments for disabled people.
